The Board will permit employees the personal use of school district facilities, equipment other than vehicles and small hand tools (tools under \$100 in value). Employees may only use facilities in which they work and have access to equipment providing that the employee's request meets the following:

- facilities can only be used outside of the normal school and working hours provided they are not being used for school programs or are booked by the school
- b) does not conflict or interfere with School District or community use
- c) for individual employee use not group use
- d) is occasional and personal, not commercial
- e) does not consume materials and supplies
- f) has no adverse effect on the condition of the facilities and/or equipment
- g) does not interfere with the regular work hours or job performance
- h) the employee is familiar with the facility and equipment and the employee is competent to operate and has completed a written waiver of liability
- receives the prior approval of the individual responsible for the administration of the facility and receives the prior approval of the individual that occupies that part of the facility
- i) a waiver must be signed by employee prior for any use.

Exception:

Weight room facilities at Grand Forks Secondary School and Boundary Central Secondary School may be used by all School District No. 51 employees outside of normal school and working hours. No additional keys will be provided for staff members who do not work in those facilities. Employees using the weight rooms must adhere to clauses a) to j) above.
