Secretary-Treasurer's Report J. Hanlon, Secretary-Treasurer November 2017

<u>Annual Facility Grant Projects & School Enhancement Funds</u>

Dean Higashi, Operations Manager, and I are working on ensuring that all the Annual Facilities Grant Monies and School Enhancement Funds that we were allocated in April 2017 are spent by March 31, 2018.

School Enhancement Projects include:

- Chiller at GFSS
- Replacement rooftop units on various schools
- Lighting upgrade at various schools

We also submitted a Capital Plan last June that included proposed School Enhancement Fund Projects that we anticipate could be announce in April 2018. These Projects are:

- Washroom upgrades at Perley Elementary
- Upgrade plumbing at CLES, MES, BES
- Refinishing gym floors CLES, Perley, Hutton, BCSS, WBES
- Replacing GES gym floor
- Door and window replacement at Hutton

If these projects are approved in April, we are preparing to be ready to go to tender so projects can get done over the summer of 2018.

We also need to be ready for our submission for the 2019/2020 school year. We have met with the Science Departments at both secondary schools and are looking at how we could revamp their classroom space.

Transportation

The small 24-passenger bus that we ordered and received did not pass inspection. We have asked the Ministry for additional funds to replace it with a bigger bus.

Finance

I continued to work on the amended budget. I am looking forward to getting our final funding for the 2017/2018 school year. I will provide an update at the January meeting as the amended budget needs to be passed in February. I will also begin working on the 2018/2019 budget.

Equipment Grant

Dean Higashi and I continued working on the equipment replacement and new equipment that we submitted under the ITA grant that we received. This grant is funded over a three-week period. If you recall from the last meetings presentation, the robotics equipment demonstrated was purchased as part of this grant.

This report is the Statement of Financial Information Report. It is a listing of Trustees remuneration and expenses for the fiscal year 2016/2017 along with employees remuneration that is over \$75,000 and any vendor that is paid \$25,000 and greater.

Checking - Have we made a big enough difference? How will we know?

Intellectual:

We will measure critical thinking skills through District based measures, FSA and Graduation Numeracy Assessment.

Human and Social:

We will survey all students for anxiety levels, growth mindset, self-regulation and connectedness to school, community, place and the environment.

Career Development:

An anecdotal survey of career experiences offered will be completed by schools.


SD51 Framework Inquiry 2017/18

FOCUS - What does our District Focus need to be?

Intellectual: Developing students critical thinking skills through a focus on Writing, Numeracy and Executive Functioning and experiential learning

Human and Social: Developing Self-Regulation and Growth Mindset skills in our students and staff while focusing connectedness to place and the environment.

Career Development: Provide greater hands on design and experiential learning opportunities for students. Build stronger connections between School, Community, Post-Secondary and the work place.



Take Action - What can we do as a District to make a meaningful difference on our *Focus*?

Intellectual: Carol Fullerton sessions will provide instructional strategies in Numeracy that will translate into classroom practice. Providing multiple opportunities for our staff to participate in professional learning to strengthen classroom practices

Human and Social: Through the work of Leyton Schnellert and Shelley Moore, we are developing student focused classrooms that are structured to reduce anxiety and be student strength based.

Career Development: Each school to provide hands on learning opportunities for all students based on design thinking and product creation. Provide increased access for students to Trades training and experiences.

Developing a Hunch - What is leading to these situations?

Intellectual: The District needs to put a stronger focus on students' ability to think about and reflect on their learning.
Student ownership of their learning, needs to be further developed.

Human and Social: The District needs to further develop our student focused, inclusive and welcoming classrooms. We have observed a decrease in connectedness to community, home and the environment.

Career Development: We need to increase access and opportunities for hands-on experiential learning in all grades.

Learning - What do we need to learn?

Intellectual: All schools are engaging students in thoughtful processes to help develop thinking skills embedded in learning. Carol Fullerton is leading professional learning with all Primary and Intermediate teachers in numeracy.

Human and Social: The District has formed learning partnerships with Leyton Schnellert and Shelley Moore to support human and social learning. Deeper understandings of Growth Mindset, Self-Regulation and Executive Functioning are being pursued.

Career Development: Providing teachers concrete learning sequences that focus on student design theory and hands on learning opportunities. Develop comfort in giving students a greater opportunity to show what they know in meaning ways.

The Board of Education recognizes the existence of the Copyright Act which is designed to protect the rights of authors and producers of creative works. The Board further recognizes such works should not be copied without the permission of the copyright holder. The Board advises its employees to respect copyright provisions as they pertain to all aspects of digital and printed materials, media, databases and computer software.

REGULATIONS

1.0 Copyright Guidlelines

- 1.1 Copyright violations occur when copyrighted materials are used in the classroom or school without the permission of the copyright holders.
- 1.2 All employees should refer to www.copyrightdecisiontool.ca for acceptable uses and violations.
- 1.3 Teachers are to ensure that students under their supervision are informed of copyright expectations.
- 2.0 Administrator and Supervisor Responsibilities

That employees under your supervision are:

- 2.1 Informed of copyright legislation and Board Policy.
- 2.2 Aware of the copyright decision tool.
- 2.3 Applying and adhering to this policy.
- 2.4 Not using district hardware to torrent copyrighted media. (i.e. music, movies, TV shows).
