1. Presentations/Discussion

- Ken Keys BCSS Basketball Coach
 - New basketball program introduced at BCSS, aligns with programs at bigger schools/districts. Goal is to get students to college by way of scholarship.
 - Requesting support of the program by the Board, including consideration of someone to write grant applications.

2. Strategic Plan Update

- Superintendent Lautard presented the Strategic Plan update:
 - BCSS student trustee Taylor Ramsay provided an update of recent events at the school including: Grade 12 capstone presentations, Grade 10 and 12 completed numeracy and literacy assessments, theatre production in February (tickets available through BCSS office), Senior French class is in Quebec for exchange program, and Spirit Club plans for dress-up days
 - BCSS student trustee Elizabeth Tsignoias provided an update of recent initiatives including: Surveying students on school's late policy and how they can strengthen student and local law enforcement relationship. Will be making a presentation to the police asking them to encourage students to stop disrespecting the community during lunch
 - Completed mastery section of Circle of Courage
 - o Update from the Health Promoting Schools Coordinator, Carol Mitchell
 - Education Committee update

3. Committee Reports

FINANCE

- Secretary Treasurer Burdock presented the expenditure report to December 31/2023
 - Represents 6 months of fiscal and 4 months of school year
 - Salaries and benefits continue to track as expected with exception of substitute costs
 - The Okanagan Labour Relations Council is supporting implementation of an Attendance Support & Wellness program in the District, will be able to share more information about the program and attendance data in the coming months
 - Supplies and services are also tracking as expected, with minor inflationary and unexpected maintenance items which will be addressed through the amended budget
- Secretary Treasurer Burdock presented the 2023/2024 Budget Update
 - The Recalculated Operating Grant was announced in December
 - Based on September 30th student data count, grant is up just over \$518,000 from preliminary grant as a result of increased student enrolment and level 2 student claims
 - Initial draft Amended Budget has been prepared
 - Annual budget passed last June based on enrollment projections and initial staffing. After adjusting for recalculated grant and actual staffing, reporting surplus of \$500K; however, still need to consider substitute costs, benefit rate changes, school budgets based on actual enrolment and any other known changes
 - Final amended budget to be adopted and submitted by February 29th

OPERATIONS

- Secretary Treasurer Burdock presented the Long-Range Facilities Plan Process Guiding Principals
 - Timeline was approved in December and senior management is requesting direction from the Board on what lenses to use as initial recommendations are put together
