Business Items

1. Presentations/Discussion

- Julie Mercer, Health Promoting School Food Coordinator
 - Feeding Futures Program Visited schools in September to meet with PVP/staff to identify successes/challenges with current food programs and support expansion and stabilization of those programs. Focus on facility upgrades, including purchasing equipment and appliances and developing sanitation and food preparation procedures. Also working towards procurement centralization and creating Food Service Assistant position.

- Food for Families Program Continuing to provide food hampers to support food security for families at home. Focus on more efficient procurement and delivery practices.
- Goal to provide food literacy support and resources for teachers and students.

2. Strategic Plan Update

- Superintendent Lautard presented the Strategic Plan update:
 - BCSS student trustee Taylor Ramsay provided update on Spirit Club events, Youth Advisory Council work on empathy and belonging, seniors' grad fundraisers, random acts of kindness, ski program at Phoenix Mtn, theatre class performance, and boys' basketball
 - ADST with Peter Scott
 - Circle of Courage: Independence

3. Committee Reports

FINANCE

- Secretary Treasurer Burdock presented the expenditure report to January 31, 2024
 - Represents 7 months of fiscal year and 5 months of school year
 - The amended budget addresses the major variances presented in the report, particularly substitute costs.
- Secretary Treasurer Burdock presented the 2023/2024 Amended Budget and highlighted the following:
 - No significant changes in staffing levels from original budget. Wage increases result of recording actual teacher salary compared to average salary, and teacher increments.
 - Two major areas of operating budget increase are: Substitute costs to cover increasing employee absenteeism and benefit costs for increased dental and extended health premiums and WorkSafe BC premiums.
 - o Overall, \$10K from accumulated operating surplus required to balance operating budget.
 - Special Purpose Fund expenses increased \$573K from the annual budget, with majority of the increase related to Classroom Enhancement Fund (CEF) – Staffing as claimed 11.95 teacher FTE compared to 8.375 in original budget.
 - No change in transfer of \$250,000 from Operating to Local Capital reserve per original budget.
