  - Great gains in reading assessments
    - Teachers are able to plan their instruction based on where the students are at
    - Questions if students are genuinely learning

## 3. Committee Reports

#### **FINANCE**

Secretary Treasurer Burdock explained new requirements implemented in 2022 through adoption of new financial management policies to improve transparency and accountability. Next two topics are result of this implementation.

- Secretary Treasurer Burdock presented the Local Capital Continuity Schedule and explained Local Capital is a reserve fund used to purchase items the Ministry does not fund, typically white fleet replacements and technology purchases.
  - Per the schedule, balance in Local Capital at June 30, 2023 is \$713K and purchases over the next 3 years estimated to be approx. \$1.5 mil. As such, \$850K required over next 3 years.

"That the Board of Education approve a transfer of \$250,000 from operating to Local Capital at June 30, 2023 to fund planned expenditures over the next 3 years as presented"

- Secretary Treasurer Burdock presented the Internally Restricted Surplus Operating Fund
  - Allocations within the operating surplus were previously approved through the adoption of the financial statements. Amended operating surplus policy now requires separate motion to approve all internal restrictions.
  - 4 categories of restrictions per Note 18, with most notable being the unrestricted balance of \$590K, with represents 3% of average operating expenditures.

"That the Board of Education approve the Internally Restricted Accumulated Operating Surplus as detailed in Note 18 of the Audited Financial Statements for the year ended June 30, 2023."

- Secretary Treasurer Burdock presented the 2022/23 Audited Financial Statements
  - The Statement of Financial Position and the Statement of Operations are the main audited statements
    - Significant change on the Statement of Financial Position is related to adoption of Canadian public sector accounting standard PS 3280 – Asset Retirement Obligations, which resulted in reporting of an ARO liability of \$4.77 mil and \$4.76 mil decrease to opening Accumulated Surplus – Capital Fund
    - The Statement of Operations reports a deficit for the year of \$774K, which includes deficit of \$718K in operating fund and deficit of \$57K in capital fund.
- Secretary Treasurer Burdock explained the 2022/2023 Financial Statement Discussion and Analysis is a companion document to the financial statements to improve transparency and understanding. The FSD&A was first introduced in 2022. It is not audited and does not require formal approval from the Board, but will be made available to the public on the District website with the approved financial statements.

### **OPERATIONS**

- Secretary Treasurer Burdock provided a summary of approved capital projects in 2023/2024 and highlighted two items:
  - \$195,000 received to resurface Perley playground and add accessible equipment.
     Project is expected to be completed in early October.
  - Approved for two electric buses in the 2022/23 capital plan, one of which has a wheelchair lift. Both buses currently unavailable due to delays and safety recalls.
     Timeline reviewed.

- Secretary Treasurer Burdock presented the 2024/2025 Five-Year Capital Plan Minor Capital Programs submission, which is due September 30<sup>th</sup> to the Ministry.
  - Requesting \$1.55 mil under the School Enhancement Program and \$875K under the Carbon Neutral Capital Program. No requests for the Playground Equipment Program, Bus Acquisition Program, or Building Envelopment Program.
  - o Approved projects will be announced in March 2024.
