Business Items

1. Strategic Plan Update

- Superintendent Lautard presented the Strategic Plan update:
 - o BCSS student trustees Elizabeth Tsigonias and Taylor Ramsey provided an update
 - Recent events include: Remembrance Day ceremony, Western Day,
 Halloween costume contest, jersey day, Clothing drive, Road runner day
 - Hot lunch and breakfast programs continue to thrive

- Sports teams continue to be busy
- French class fundraising for Quebec trip in January
- o GFSS hoping to have student representation soon
- Joanie Holmes supporting Circle of Courage work and trying to build community within the transition years
- Next Education Meeting will be looking at Fall Reading and Writing Assessments
- o FSA's completed on November 9th and marked on the 17th
- New tracking system for Indigenous Education Department
- Accessibility Survey update
 - Student survey will be sent out in the coming weeks

2. Presentation

- Kirsten Rezansoff Seamless Day Pilot Project
 - Opened September 18th and fully staffed by September 27th
 - 10 students consistently using program and seeing enrolment growth over time
 - Goal to increase enrolment to full capacity to ensure program sustainable
 - Challenges include not meeting need for Friday care for families and no casual staff in place for coverage

3. Committee Reports

FINANCE

- Secretary Treasurer Burdock presented the expenditure report to October 31/2023
 - Showing 4/12 months of the fiscal year and 2/10 months of the school year
 - Had increased enrolment in September and added staffing which is not reflected in the budget; however, salaries and benefits are tracking as expected
 - Monitoring Substitute Costs. Costs were high last year, watching to see if trend continues. First two months indicate similar trend to 2022/23 at 71% unspent. Will continue to monitor and perform analysis to better understand type of absences.
 - Furniture and equipment showing overspent as GFSS used carry-forward balance to replace furniture and equipment in the staff room.
- Secretary Treasurer Burdock presented the 2023/24 Budget Process
 - Draft based on timeline/process followed over the past few years; however, goal to improve public consultation as feedback on World Café model not positive.
 - o Discussion on options to increase staff and parent participation.

OPERATIONS

- Secretary Treasurer Burdock presented the Long-Range Facilities Plan Process
 - Shifting from an external consultant to an internal process as value lies in the process rather than the end document.
 - Senior staff will develop initial recommendations and then seek input from all stakeholders on those recommendations.

5. Senior Management Reports

- Superintendent Lautard presented her report and highlighted the following:
 - Legislation changes to the *School Act*
 - Do not have Local Education Agreements (LEA's) here and already have an established Indigenous Education Council
 - Rise in anti-Semitism and it was found there was not explicit language in the curriculum regarding the holocaust

- Secretary Treasurer Burdock provided a verbal update and highlighted the following:
 - Professional development throughout October and November, including IBM K-12 in Boston, BCPSEA Symposium and now at the BCASBO Fall Conference and BCSTA Trustee Academy.
 - Also participated in annual meeting with the City of Grand Forks regarding shared fiber optic network.
 - District maintains internal reserve, which is funded by each party annually, for the maintenance/replacement of the network. SD51's IT department maintains an inventory and replacement schedule. A review of the replacement plan concluded increased funding will be required over the next 5 years, which will be reflected on the 2024/25 budget
 - o Patrick McCarron started work as new Operations Manager welcome!
 - All recalls on non-accessible electric bus completed and it is being piloted on routes in Grand Forks
