 - Represents 5 months of fiscal and 3 months of school year. Salaries and benefits are tracking as expected, with exception of replacement costs which continue to trend high. Preliminary analysis in absence tracking system indicates absences by reason code are consistent with past 2 years. Consideration going forward on whether District can take any action to reduce employee absences. One option is to inform employees of their absences as an awareness campaign.
- Secretary Treasurer Burdock presented the 2024/25 Budget Process
 - Public consultation process is going to be through online surveys and school-driven forums to ensure connection to school growth plans and strategic plan. Trustees encouraged to attend in-person events at their liaison school.
 - Will be separate from the long-range facilities process to honor uniqueness and importance of both budget and LRFP.
