EDUCATION

Class Size & Composition

• One grade 6/7 class is over 30 at Christina Lake Elementary (CLES). Learning Improvement Funds have been provided to support the teacher. The principal has reported that by mid-October the intermediate classes at CLES will be down to 28 and 29.

Professional Development (Staff)

- Jennifer Turner has returned from a provincial Erase Bullying worship for District Leads on this initiative.
 Jennifer will be presenting at the Board Meeting and providing details.
- Additional pro-d was organized by the Director of Instruction and her report will provide information on these
 initiatives.

District Initiatives

- The "Pathways Program" in partnership with Selkirk College has been well received by students. There is a waiting list. (See attachment for details).
- A team of teachers from Hutton who are participating in the Changing Results for Young Readers initiative have merged this initiative with an International Study of SmartLearning. The University of Otago in Dunedin New Zealand granted approval for a research project designed to examine the impact of the SmartLearning project on student outcomes. The aims of the study are to identify the key elements of the research-informed practice used by the teachers, and to assess the impact of that practice on student outcomes. The questions of this study are:
 - What are the key elements of the research-informed practice used by the teachers in the *SmartLearning* project?
 - What is the impact of this practice used by the teachers in the SmartLearning project on student outcomes?
- Fire Suppression continues to be offered by the District. Retired principal Walt Osellame is the instructor. This year 2 linear blocks are being offered. This program is outside the regular secondary school timetable.
- Community Network Joint Use Agreement has been signed and is now in effect.

It allows users to manipulate and display data in a variety of formats using interactive dashboards that are designed to support analytical functions rather than day-to-day data transactions. 
Operations/Transportation Report September 2012 J. Hanlon, Secretary-Treasurer

Ministry Forms - During the month of September we gathered the data for Ministry reports due in October. The official snapshot date for reporting was September 28th. We worked closely with school secretaries, aboriginal education and special education teachers throughout September and therefore we dealt with very few discrepancies. We ran test downloads the last week in September as well as processing the data through the Ministry verification software to analyze the information and address any issues before September 30th. This process enabled us to submit our forms on time.

<u>Technology</u> – The Technology Department is continuing to deploy computers for the Special Education departments in our schools. Trouble shooting issues created by the installation of new equipment is always a focus in September.

<u>Superintendent Search</u> – The Board is currently advertising for the position of Superintendent of Schools. In September the meeting was held with stakeholder groups seeking input. The Board hopes to have the candidate selected by the end of November or early December.

<u>Operation Committee</u> - At the Operations Committee we discussed the annual facilities grant projects that were completed over the summer, comparing the budgeted





Costing for the Middle School in Grand Forks

Using the September 2012 actuals and projecting the same number of kindergarten students that we had this year, I looked at class configurations over the next three years and projected costs or savings that the District would see comparing the middle school configurations to the status quo. In year one there is a cost of approximately \$40,000 and in the following two years a savings of approximately \$40,000 each. 
EDI PARTICIPATION

HELP collects data in two year cycles or "waves", allowing for province wide participation over that time. The 2011/12 data collection is the first year of Wave 5. Boundary has participated in each of the previous 4 waves. In 2011/12 7 schools participated in the project.

These results are provided on an interim basis only. Complete results for Wave 5 will combine EDI data collected in Boundary in both the 2011/12 and the 2012/13 school year. The results for the complete wave will differ from this single year of data.

NEW NEIGHBOURHOODS

In an effort to improve our reporting of EDI results and to limit the need to suppress data, HELP has worked with community contacts to revise neighbourhood boundaries in some areas. 2011/12 EDI data is reported by these new neighbourhood boundaries. Once Wave 5 data collection is complete, previous Waves will also be reported by the new neighbourhoods so trends can be studied.




2011/12 EDI RESULTS

Overall, Boundary had a vulnerability rate of 30%. The vulnerability rate in the last data collection (Wave 4) was 29%.

District wide, the highest level of vulnerability was on the Emotional Maturity scale at 14%. The smallest proportion of children vulnerable was on the Language & Cognitive Development and the Communication Skills and General Knowledge scale at 9%.

THE PROVINCIAL CONTEXT

The EDI data from over a decade of research shows that province-wide about 30% of children in kindergarten are vulnerable in at least one aspect of their development.

The vulnerable children in B.C. are not spread evenly throughout the province. EDI research reveals a large "geography of opportunity" where some children face steep difficulties and others do not. The disparity is significant: on the low end, some neighbourhoods have rates of vulnerability below 5% while others over 60% Figure 2 shows how vulnerability rates in SD5 compare with other school districts in the province.

COMMUNITY ACTION

Children's development is influenced by a variety of factors, among them: genetics, family environment, socio-economic conditions, neighbourhood influences, availability of early child development services, and policy directions.

Changes in the state of children's development at the level of the population will be as a result of the interplay of these factors in a community. EDI results can be used to guide community planners and policy makers in making decisions about priorities for early child development supports and services, but they cannot be accurately used to evaluate one aspect of the environment, or one specific program, in isolation from the others.

Community action groups will have more impact if they have the following elements:



Strong intersectoral leadership



A focus on local EDI outcomes



Alignment between the school system and the early care, learning and development sectors



A plan to increase access to service by decreasing barriers for families; and



A commitment to advocacy
