- (c) Maintain proper books of account, and other information and documents with respect to the affairs of the Project, as may be prescribed by the Minister.

NOW THEREFORE the Board enacts as follows:

- 1. The Capital Bylaw of the Board approved by the Minister and specifying a maximum expenditure of \$9,765.00 for Project No. 126580 is hereby adopted.
- 2. This Bylaw may be cited as "School District No. 51 (Boundary) Capital Project Bylaw No. 126580.

Secretary-Treasurer's Report September 2013 Jeanette Hanlon, Secretary-Treasurer

Ministry Forms - During the month of September we gathered the data for Ministry reports due in October. The official snapshot date for reporting is September 30th. We work closely with the school secretaries, aboriginal education and special education teachers throughout September, so we deal with very few discrepancies. We do test downloads the last week in September and run the data through the Ministry verification software to analyze the information and address any issues before September 30th. This process enables us to submit our forms on time.



<u>Technology</u> – The Technology Department continues to do trouble shooting and working on implementing new UPS's as well as finishing the installation of the new VOIP systems. Trouble shooting issues are created by the installation of new equipment and image upgrades done during the summer months. This makes for a very busy month of September. The Tech Department has also been helping the City with relocation plans after the fire at City Hall.

<u>Pro D for Support Staff</u> – On September 27th we provided three different sessions for bus drivers, custodians and supervisors. The bus driver sessions included bus discipline protocol with Superintendent, Kevin Argue, and then they heard from Jason Odland, Department of Transportation, regarding pre trip protocol and paperwork. The custodians attended sessions with Brent Bourne who is a custodian instructor from Victoria. He discussed product usage as well as ways to maintain clean schools. The supervisors attended a session on self-regulation presented by the Director of Learning, Doug Lacey. He also led them through the yearly District safety orientation. Lynn Heriot and Anthony Bautista presented to each of the three groups regarding the use of first class, timesheet entry and maintenance, as well as how to produce IT request.

<u>Operations</u> - Maintenance has been completing some summer projects and focusing on work orders.

Leadership Committee – BCASBO

I have agreed once again to be on the BCASBO Leadership Development Committee. The planning for the Leadership series over the next two years will be done via conference calls. There will be four sessions that I will be attending as a group facilitator. I have found this Committee and work to be very useful and a great pro-d opportunity.

Staff Learning and School Visits

- September 6th Attended pancake breakfast and PAC meeting in Beaverdell Elementary. Also visited Administration and classrooms in WBES, MES, BCSS, and GES.
- September 9th Visited two classrooms in Perley Elementary and two classrooms in GFSS
- September 12th Visited classrooms at CLES
- September 17 Visited two classroom at Perley Elementary and two classrooms at GFSS.
- September 23rd Visited Administration and 4 classrooms at Hutton Elementary





- September 25th Visited one classroom at GFSS
- September 27th Held an in-service for School District noon-hour and after-school supervisors on student self-regulation, and improving effectiveness of hallway and playground supervision.
- October 30th Attended Community Literacy Advisory Meeting. Will sit on a working

committee for an anthology writing project called "Writing Through Time", proposed by Leslie Davidson. This will be an opportunity for all school ages.

Special Education and Student Services

 September 11 – Joanne Gidney and I travelled out to WBES, MES, BCSS, GES to meet with School Administration and



special ed staff. Our goal was to understand the learning profiles of their students with special needs, and meet as many as we could. We discussed ways we can provide support this year.

The day was spent focusing on improved start-up procedures and referral processes, and assessment pathways, reviewing provincial outreach and pro-d services, as well as discussion of Education Assistant capacity training and models of classroom support. Brenda Fitzner, District Psych. Ed., spoke to the group. The afternoon was spent on team mentoring and IEP writing.

 Joanne Gidney has been visiting school special education staff, and observing students to support intervention plans during her District Wednesdays. She has also been reviewing referral packages and developed the special ed pro-d day.





- September 19th One class from CLES, Greenwood, WBES, and two classes from Perley travelled to Kelowna to participate in a pow-wow. This was targeted at the Grade 4/5 level. Wanda Hecht oversaw this event
- September 19th Truth and Reconciliation Education Conference was held at the Pacific Coliseum and PNE grounds. Four secondary students from

BCSS and two students from GFSS attended, as well at Marilyn Hanson, Joan Holmes (elder) and I attended this event with the students. Over 4000 students were in attendance at this Provincial and National event.
