# Re: School Immunization Program Updates

The purpose of this letter is to provide information about the 2019/2020 school immunization program. This year, Interior Health (IH) will be taking on several new initiatives as part of the provincial <u>Vaccine Status Reporting Regulation</u> (VSRR). In addition to these new initiatives, we will continue to provide the annual routine school immunization program for students in grades 6 and 9.

#### **VACCINE STATUS REPORTING REGULATION**

On July 1, 2019, the B.C. Government approved the Vaccination Status Reporting Regulation under the Public Health Act. This regulation requires that parents or guardians report the vaccination status of their school-aged children to their local health authority.

#### Collection of records and student privacy

- Schools are <u>not expected</u> to contact parents and request student records. Parents and guardians are responsible for gathering and providing missing immunization records.
- Missing records can be provided to a <u>local public health centre</u> or the child's school for collection by the school nurse. Records provided to the school nurse must be provided in a sealed envelope. If parents/guardians provide loose immunization records, school staff are asked to provide parents with an envelope to place records in and seal. Immunization records are then to be stored in a secure compartment until they can be picked up by the school nurse. Schools are required to report any breaches of privacy and provide details of corrective actions taken to the School Nurse. Privacy breaches are reviewed by the IH Risk & Privacy Department.

## **Catch-up immunizations**

- In addition to updating missing and incomplete records, Interior Health will be providing catchup immunizations to students in kindergarten, grade 1, 6, 9, 11, and 12 for the upcoming year.
- Catch-up immunizations will be provided in public health centres or school clinics depending on the area and age of students.

## 2019/2020 SCHOOL IMMUNIZATION CLINICS

There have been no vaccine changes to the annual school immunization program for grade 6 and 9 students. The routine school vaccines are:

- · Grade 6: Hepatitis B, HPV9 (Gardasil®9) and Varicella
- Grade 9: Tetanus/Diphtheria/Pertussis (Tdap) and Meningococcal Quadrivalent

School nurses will be approaching school principals to discuss organizing school clinics for annual routine immunizations and catch-up immunizations and the type of space that is required.

# Consent packages and student privacy

- Consent packages for all school immunization clinics (annual grade 6 and 9 immunizations, as
  well as new catch-up clinics) will be provided to schools by Interior Health. Parents/students are
  asked to return signed consent forms sealed in the envelopes provided. If parents/students
  provide loose consent forms, school staff are asked to provide them with an envelope to place
  consent forms in and seal.
- Returned consent packages are to be stored in a secure compartment until they can be picked
  up by the school nurse. Schools are required to report any breaches of privacy and provide
  details of corrective actions taken to the School Nurse. Privacy breaches are reviewed by the
  IH Risk & Privacy Department.

## **Mature Minor Consent (MMC)**

• Students in grades 9, 11, and 12 can provide Mature Minor Consent to immunization as per the legislation under the Infants Act.
